ORDER:

In the reference 1<sup>st</sup> read above, Government while has taken into consideration the crisis in Powerloom Sector. Accordingly, as per the recommendations of the Andhra Pradesh Electricity Regulatory Commission (APEREC), Government has accorded sanction to provide relief in power tariff and reduced power tariff for Powerloom units from Rs.1.74 per unit to Rs.0.87 per unit upto 5 HP load w.e.f. 1-10-2001. Accordingly, Government have been sanctioning amounts to APTRANSCO, for providing power tariff concession to Powerloom units from 1-10-2001 on wards. Governments have accorded permission for continuation of the scheme from time to time upto 31-03-2010.

2. In the reference 4<sup>th</sup> read above, the Director of Handlooms has requested the Government to sanction Rs.3274.24 Lakhs towards the arrears from 01-04-2010 to 31-03-2011 (actual claims made) and Demand for the year 2012-13 @ 2.67 unit cost as per estimates of the Andhra Pradesh Transmission Corporation (APTRANSCO).

3. In the reference 6<sup>th</sup> read above, an amount of Rs.649.99 Lakhs was sanctioned towards payment of arrears due to APDISCOMs as on 31/03/2010 as per the actuals furnished by APTRANSCO, Hyderabad.

4. In the reference 8<sup>th</sup> read above, the Director of Handlooms and Textiles has requested the Government, to sanction the balance amount of Rs.2526.98 Lakhs under 50% Power Tariff Concession Scheme to Powerloom Weavers in the State, as per the actual claims made by the Dy. Chief Controller of Accounts of Andhra Pradesh Transmission Corporation.

5. Government, after careful examination of the matter decided and accordingly hereby order:

- a). to continue the Power Subsidy Scheme from 01-04-2010 to 31-03-2012 and also after 01-04-2012, and
- b). to sanction an amount of Rs.2526.98 Lakhs (Rupees Twenty five crores twenty six lakhs and ninety eight thousand only) under 50% Power Tariff Concession Scheme to Powerloom Weavers in the State.

6. The expenditure sanctioned in para 6 above shall be debited to the following Head of Account:-

7. The Director of Handlooms and Textiles is authorized to issue a cheque/draw and disburse the amount to the concerned for the purpose for which it is sanctioned.
