ORDER:-

In the G.O. 1st read above, Govt. have issued orders approving the scheme for reimbursement of 10% subsidy on purchase of Hank Yarn, Dyes and Chemicals, purchased from NHDC and its Depots and APCO w.e.f.01-01-2008.

- 2. In the G.O. 2nd read above, Government have issued orders for implementation of the Scheme for reimbursement of yarn subsidy with additional 10% subsidy w.e.f. 1.1.2011 totalling to 20% subsidy on purchase of good quality and branded Hank yarn and quality Dyes & Chemicals from NHDC and APCO, which is to be genuinely utilized for production of Handloom fabrics.
- 3. In the Lr. 3rd read above, the CH&T has informed that the weavers representatives and the Handloom weavers Cooperative Societies from various parts of the State are constantly representing for modifications in the scheme so that a part of the amount is distributed to the weavers as incentive and the remaining is utilized by the societies for giving rebate on sale and requested to issue orders on implementation of the 20% yarn subsidy scheme, duly providing following mode of utilization for the amount sanctioned under the scheme:
 - i) Out of the amount sanctioned as 20% yarn subsidy, 50% amount will be credited directly to the members Bank Account of the concerned Primary Weavers Coop. Societies as Production bonus basing on the wages earned by them; and ii) The societies may utilize the remaining 50% amount for giving Rebate on Sales or for any other production related purpose.
- 4. Govt., after careful examination of the proposal hereby order to utilize the amount sanctioned under 20% yarn subsidy, in the following pattern:
 - i) Out of the amount sanctioned as 20% yarn subsidy, 50% amount will be credited directly to the members Bank Account of the concerned Primary Weavers

Coop. Societies as Production bonus basing on the wages earned by them; and ii) The societies shall utilize the remaining 50% amount for giving Rebate on Sales or for any other production related purpose.

- 5. The CH&T shall take necessary further action in the matter.
- 6. This order issues with the concurrence of Finance Department vide their U.O.No.45027/281/2016, Dt.06.09.2016.
