Sub: Sanction/release of financial assistance towards construction of Individual worksheds for interventions other than Assisted Clusters in different Handloom Pockets of Andhra Pradesh State under National Handloom Development Programme(NHDP) -reg.

Sir,

I am directed to convey sanction of the President of India for sanction of total project cost of Rs.320.40 lakh consisting Central share of Rs.304.20 lakh, beneficiary share Rs.16.20 lakh and to release of Rs.3,04,20,000/- (Rupees Three Crore Four Lakh Twenty Thousand only) as full and final installment of GOI share for incurring of non-recurring expenditure in favour of Director/Commissioner of Handloom & Textiles, Government of Andhra Pradesh for providing financial assistance for construction of Individual worksheds for interventions other than Assisted Clusters in different Handloom Pockets of Andhra Pradesh State under National Handloom Development Programme(NHDP) during the year 2023-24. However, the funds will be routed through Central Nodal Agency i.e. National Handloom Development Corporation Limited (A/c No.- 218301001603, IFSC Code – ICIC0002183). 2. The sanction is issued in accordance with following conditions:-
i. No UC is pending against the said organization under any Scheme of the MoT;

- ii. The expenditure may be incurred on approved eligible components as per the guidelines of the Scheme;
 - iii. Impact Report for each cluster project is received & accepted by the O/o DC(HL);
 - iv. The fund proposed to be released will be spent for the purpose for which sanctioned & there will be no deviation of fund for any other purpose;
 - v. State Government may ensure beneficiary has not availed similar financial assistance for same purpose from Govt./Non-government organization before releasing fund;
 - vi. There will no duplication on efforts on part of Gol on implementation of these projects.
 - vii. The assets created out of Government grants shall not be disposed of without the proper approval of the MoT;
 - viii. Quality and physical verification of the items supplied shall be done jointly by the official of the WSC concerned and State Directorate of Handloom & Textiles. It should be completed within 15 days of the installation.
 - ix. In case, cost of any item comes out to be more than the prescribed cost in the guidelines of scheme, shall be borne by the beneficiary.
 - x. The amount being released is utilized in accordance with the scheme guidelines and other relevant terms & conditions;
 - xi. WSC concerned shall be responsible for conducting test checks to ensure adherence to quality of supplied material as per sample displayed, and also the timelines assured for delivery.
3. To draw the amount of Rs.3,04,20,000/-, the Organisation shall submit the following documents:
- a) Pre-receipted bill (in triplicate), duly revenue stamped and signed by authorized signatory.
 - b) Certificate to the effect that No Utilization Certificate of earlier release (s) is pending under any scheme of the Office of the Development Commissioner for Handlooms and Ministry of Textiles.
 - c) Certificate to the effect that the IA has been using PFMS (EAT) Module as per instruction of Ministry of Finance.
4. The expenditure of Rs.3,04,20,000/- will be debitible to following Major Head- "2851.00.103.48.01.35"- Grants for creation of Capital Assets, Demand No.98 of Ministry of Textiles for the year 2023-24.
5. This sanction issues with the approval of Integrated Finance Wing of the Ministry of Textiles vide e-file no.57524, Note#9 dated 15.12.2023.
