## ORDER:

In the G.O 1<sup>st</sup> read above, Government has introduced Andhra Pradesh Textile, Apparel and Garments Policy 4.0 (2024-29) to capture latent potential in textiles value chain and support weaving, knitting, preparatory processing, technical textiles and integrated units and announced competitive and best package of incentives to Textile and related industries.

- 2. In the G.O 2<sup>nd</sup> read above, Government has introduced AP MSME & Entrepreneurship Development Policy 4.0 (2024-29), for upliftment of MSMEs in the state and also announced competitive and best package of incentives to MSMEs and Entrepreneurs.
- 3. In the letter 3<sup>rd</sup> read above, Commissioner of Handlooms & Textiles, A.P., has examined the changes to be made in Andhra Pradesh Textile, Apparel and Garments Policy 4.0 (2024-29) in alignment with amendments made in MEDP 4.0 and submitted the revisions in Andhra Pradesh Textiles, Apparel and Garments Policy 4.0 (2024-29) to the Government.
- 4. In the G.O 4<sup>th</sup> read above, Government have issued additional benefits to Backward Community led MSMEs, to create a level playing business environment three prominent support interventions in the policy for entrepreneurs from backward communities i.e., Capital Expenditure, Power Cost, Land Cost. In the said GO, at para 6, mentions to make necessary correction as made in MEDP 4.0 policy, in respective sectoral policies.
- 5. Government after careful examination, hereby issue the following amendment/additions to Andhra Pradesh Textiles, Apparel and Garments Policy 4.0 (2024-29) issued vide G.O.Ms.No.89, I&C (Prog-II) Department, Dt:11-12-2024.

## (i) Para 4 of Contents 5.2 i.e., Power cost reimbursement, pg 10 shall read as follows:

 MSME enterprises shall be able to claim power cost subsidy at INR 2 per unit with maximum caps as tabulated below:

| Category | Subsidy                                    | Cap on Subsidy              |
|----------|--|-----------------------------|
| Micro    | Rs 2 per unit (cap. Rs. 2 lakh per annum)  | For Five (5) years from DCP |
| Small    | Rs 2 per unit (cap. Rs. 10 lakh per annum) | For Five (5) years from DCP |
| Medium   | Rs 2 per unit (cap. Rs. 30 lakh per annum) | For Five (5) years from DCP |

### (ii) Para 5 of content 5.2 i.e., Electricity Duty exemption, pg 10 shall read as follows:

 MSME enterprises shall be eligible for 50% exemption on electricity duty cost for 5 years from DCP

#### (iii) Para 6 of content 5.3 i.e., Power cost reimbursement, pg 13, shall read as follows:

 Sub Large and above category enterprises shall be able to claim power cost subsidy at INR 2 per unit for 5 years from DCP, limited to maximum incentive as tabulated below.

| Category  | Subsidy                       | Cap on Subsidy              |
|-----------|-------------------------------|-----------------------------|
| Sub Large | Rs 2 per unit (cap. Rs. 1 Cr) | For Five (5) years from DCP |
| Large     | Rs 2 per unit (cap. Rs. 2 Cr) | For Five (5) years from DCP |

#### (iv) Para 7 of content 5.3 i.e., Electricity Duty exemption, pg 14, shall read as follows:

 Sub Large and Large category enterprises shall be eligible for 50% exemption on electricity duty cost for 5 years from DCP.

# (v) Additional para shall be inserted as para-4 of content 5.4, which reads as para 4: Rebate on Land Cost:-

- 75% rebate in land cost limited to INR 25 lakhs for SC/ST, having domicile in the State, led Micro and Small Enterprises, setup in Industrial Estates/Industrial Parks developed by APIIC.
- The rebate is applicable only for new units and the incentive can be availed only once on the land.
- 6. The incentives along with above mentioned amendments to Andhra Pradesh Textiles, Apparel and Garments Policy 4.0 (2024-29) will be extended to eligible industries as per the operational guidelines, which shall be notified separately.

7. The Director of Industries, AP, Mangalagiri and the Commissioner, Handlooms & Textiles, shall take necessary action accordingly.
