I am directed to convey sanction of the President of India for sanction of total project cost of Rs.605.40 lakh consisting Central share of Rs.567.860 lakh, beneficiary share of Rs.37.540 lakh and to release of Rs.2,03,05,800/- (Rupees Two crore Three lakh Five thousand Eight hundred only) as 1<sup>st</sup> installment for incurring of non-recurring expenditure to Commissioner of Handlooms & Textiles, Govt. of Andhra Pradesh, for setting up of 04 Small Cluster Development Programmes (SCDPs) in the state of Andhra Pradesh under National Handloom Development Programme (NHDP). However, funds will be routed through notified CNA i.e. National Handloom Development Corporation Limited (A/C No.218301001603, IFSC Code- ICIC0002183) as per details given below:

2. The sanction is subject to the following conditions:-

- I. No UC is pending against the said organization under any Scheme of the MoT;
- II. The expenditure may be incurred on approved eligible components as per the guidelines of the Scheme;
- III. The above 04 SCDPs shall have a mid-term review before release of 2nd Installment as full and final payment.
- IV. The physical & financial report/ statement of expenditure may be got verified & accepted by the O/o DC(HL) before release of 2<sup>nd</sup> installment;
- V. A mechanism may be devised for monitoring the each cluster by constituting a Committee competent for reviewing the work done in the Project.
- VI. Impact Report for each cluster project is received & accepted by the O/o DC(HL);
- VII. The publicity, if any, is done in accordance with DAVP Guidelines & extant orders/instructions of Govt. on the matter;
- VIII. Previous accounts of IAs will be audited through Accountant General (Audit) before next release under the Scheme;
- IX. The amount being released is utilized in accordance with the scheme guidelines and other relevant terms & conditions;



- X. Accounts of each cluster shall be audited by the CAG of India in accordance with the provision of CAG's duties (powers and conditions of services) Act, 1971;
- XI. The fund proposed to be released will be spent for the purpose for which sanctioned & there will be no deviation of fund for any other purpose;
- XII. The State Level Project Committee (SLPC) would be responsible for overseeing and effective monitoring of each project;
- XIII. The IA shall maintain separate account of the grants received from the GOI.
- XIV. There will no duplication of efforts on part of Gol on implementation of these projects.

3. To draw the amount of Rs.2,03,05,800/- (Rupees Two crore Three lakh Five thousand Eight hundred only), the organisation shall submit the following documents:

- a) Pre-receipted bill (in triplicate), duly revenue stamped and signed by authorized signatory.
- b) Certificate to the effect that No Utilization Certificate of earlier release (s) is pending under any scheme of the Office of the Development Commissioner for Handlooms and Ministry of Textiles.
- c) Certificate to the effect that the IA has been using PFMS (EAT) Module as per instruction of Ministry of Finance.
