In the reference 1st read above, Government have issued orders for sanction of ex-gratia amount of Rs.1.50 lakhs to the families of deceased weavers who committed suicides due to poverty arising on account of occupation related distress and financial hardship, faced by a weaver in weaving profession with effect from 14.5.2004, on par with farmers.

- 2.. The Commissioner and Director of Handlooms and Textiles and Development Commissioner for Apparel Export Parks, Andhra Pradesh, Hyderabad in the reference 2nd read above has requested the Govt. to pay the ex-gratia to the families of the weavers who committed suicide from 1-4-1997 to 13-5-2004.
- 3. The Government after careful consideration of the matter, in partial modification of the orders issued in G.O Ms.No.46, Industries and Commerce (Tex) Department, dated 13.2.2006 that the benefits contemplated in the said G.O. shall be applicable to those weavers who committed suicides between 1-4-1997 to 13-5-2004 and these cases of weavers suicide deaths shall be treated in the same way as was done to the weavers' suicidal deaths in G.O Ms.No.46, Industries and Commerce (Tex) Department, dated 13.2.2006. The guidelines issued in the said G.O. shall apply for (1) Financial assistance, (2) Verification, (3) Rehabilitation package and (4) Preventive measures. However, the point to be considered additionally is that since the said weaver suicidal deaths took place quite a few years back i.e., (1997 to 2004), it may be difficult to identify the individual who committed suicide without holding a summary enquiry in the village by the Revenue Divisional Officer. Hence, after holding a summary enquiry if the Revenue Divisional Officer comes to a conclusion that the individual case under reference as a weaver suicidal death within the period referred to above, he shall conclude then and there after verification of post mortem report in the presence of the village elders belonging to weavers' community.
 - 4. Further, it shall be made mandatory for the Enquiry Officer i.e., Revenue Divisional Officer to ensure that Birth Certificate and Death Certificate issued by Competent Authority is enclosed along with the enquiry report. (PTO)

- ine relief and concessions enunciated in G.O.Ms.No.46 Industries and Commerce (Tex) Department, dated 13.2.2006 for (i) financial assistance, (ii) verification procedure, (iii) rehabilitation package and (iv) preventive measures, shall be applied mutatis-mutandis to all recognised weaver suicidal deaths enquired and cleared by the Revenue Divisional Officer and also cleared by the Committee consisting of Revenue Divisional Officer/ Sub-Collector, Deputy Superintendent of Police and Assistant Director (H&T).

The Government have looked into the several suicidal deaths by weavers took place in the State due to several reasons such as lack of work, hike in yarn prices and poverty besides ill-health and no financial assistance was provided to the deceased families by the Government. The family members of the deceased weavers were in miserable condition and Government also noticed that the families of weavers who committed suicide on account of distress caused by occupation related problems. Ilke, a) indebtedness b) lack of employment in weaving /processing c) harassment by fellow-villages on matter relating to hand loans / delivery of finished cloth etc, and d) failure in providing livelihood to family members leading to despair etc.

2. The Government in the G.O. 5th read above have constitued the Expert Committee on weavers' problems under the Chairmanship of Hon'ble Minister for Finance to study the problems of Handloom and Powerloom Weavers both in Co-operative and outside Co-operative fold with regard to production and maketing of their products and to suggest short term and long term measures by conducting field visits wherever necessary and by taking opinions of the representatives from the both

Sectors amond other things. Pending outcome of the report of the Experiment Committee on Weavers Problems submitted to Government and In the review meeting of recommendations of Expert Committee on Weavers' Problems held on 26-8-2005, the Government have decided to extend the benefit of sanction of ex-gratia amount of Rs. 1.50 lakhs to the families of deceased weavers' who committed suicide due to poverty arising on account of occupation realated distress which is an emotional trauma and financial hardship faced by a weaver, due to non-employment / marginal wages drawn in weaving profession with effect from 14-5-2004 on par with farmers. The expenditure on this account will be reimbursed from Chief Minister's Relief Fund. Accordingly, Government hereby evolved an interim special package scheme as a measure of providing assistance to the deceased weaver families of the deceased farmers:

(i) Financial Assistance:

An ex-gratia of Rs.1.00 lakh (Rupees one lakh only) in cases of suicide provisionally arises out of weaving income related issues shall be provided to the family/next of kin of the deceased weavers, as an economic support, besides loan settlement up to a ceiling/of Rs.50,000/- as one time settlement, to creditors.

The Ex-gratia of Rs. 1.00 lake to be provided to the family / next of kin of the deceased weaver may be deposited in an authorised Bank by opening joint. account of the Assistant Director (Handlooms & Textiles) of the concerned district and the legal heir.

The loan settlement up to a ceiling limit of Rs.50,000/-may be paid under proper acknowledgement to the person(s) entitled to receive it as identified by the committee and under the supervision of the Committee as one time settlement and no liabilities on the part of the deceased families will exist.

The expenditure on this account shall initially be met from out of the revolving fund of the District Collector concerned, which shall be reimbursed later from the Chief Minister's Relief Fund on receipt of necessary proposals from the District Collectors concerned, by the Government in Revenue Department.

The Government hereby constitute a committee for verfication and certification of the event of suicide comprising the following:-

The above Committee having the official jurisdiction of the place of the weavers who committed suicide shall verify each case and will establish the co-relation between the weaving related operations, economic distress and social humiliation eventually leading to suicide. It shall also further sit with bankers, Moneylenders and family members of the distressed along with the community elders and workout one time settlement package for extinguishing outstanding debts of family in distress.

(iii) Rehabilitation package:

Once the verification and certification committee clears the outstanding liabilities with Rs.50,000/- provided, weaving rehabilitation process of the distressed family shall commence. For this purpose the Territorial Officer of Handlooms and Textiles Department and the Divisional Marketing Officer, APCO having the official jurisdiction of the place of the deceased weavers and the members of the family shall decide about the future weaving operations, marketing of cloth produced by them etc.

In addition to the above, the following measures toprovide social cushion may also be taken up.

- Admission of children in Social Welfare Schools and Hostels.
- Allotment of Houses and I.A.Y. Scheme.
- ¿ Economic Support under Government Scheme.
- d. Pensions etc.

Further in such cases restriction if any regarding eligibility may be relexed by the Government in cases wherever it is considered necessary.

The distressed family members, who did not get any relief/ family assistance earlier, may submit their applications with full particulars to the Revenue Divisional Officer having the jurisdiction of the place of weaver who committed suicide. The Revenue Divisional Officer on receipt of such application may take necessary further action in the matter duly following the procedure proposed above.

(iv) Preventive Measures"

The Help line at every Collectorate may continue to operate as in the case of farmers' special package. The Assistant Director (Handlooms & Textiles) of the district and his machinery will get in touch with that family immediately and organise an appropriate counseling at District level and workout a package to insulate them from the pressures of money lenders. Such cases will be given preference in extending benefits of the ongoing Government Schemes pertaining to weaving.

3. The expenditure on a account of maintenance of the Help Line shall also be met from the Chief Ministers' Relief Fund.

- All the District Collectors / Commissioner and Director Handlooms and Textiles and Development Commissioner for Apparel Export Parks, Andhra Pradesh, Hyderabad / all Assistant Directors (Handloom & Textiles) in the State are requested to initiate necessary action immediately in this regard.

The Government have looked into the tragic incidents of suicides in the recent past by the farmers in various parts of the State. The reasons for committing such suicide may be various. The Natural calamities like successive droughts and pest attacks, mounting of debts year after year consequent, social humiliation faced by the family, financial extortion and psychological trauma resulting in social disconnect are leading to eventual suicides. It is not only a tragedy for their families by loosing their oreadwinner, but also the State by loosing a farmer.

- The Government in the G.O.cited have constituted a Cabinet Sub-Committee of formulate measures to deal with the situation arising out of such suicides. Pending outcome of the report of the Cabinet Sub-Committee, the Government have decided to provide financial assistance as an interim special package to support the families of the farmers who commit suicide.
 - Accordingly, the Government hereby evolved as an interim special package as a measure of support to the distressed family members, which will be implemented at the three levels as indicated below:

(i) Financial Assistance:

An ex gratia of Rs.1.00 Lakh (Rupees one lakh only) in cases of suicide provisionally arises out of farm income related issues shall be provided to the family/next of kin of the deceased farmer, as an economic support, besides loan settlement up to a ceiling of Rs.50,000/- (Rupees fifty thousand only) as one time Settlement. to creditors.

The ex gratia of Rs.1.00 Lakh to be provided to the family/next of kin of the deceased farmer shall be deposited in an authorized Bank by opening Joint account of M.R.O., and the legal heir. It will be operated by the Mandal level. Rehabilitation Committee Officer concerned, having the official jurisdiction of the place of the farmer who has committed suicide.

The loan settlement up to a ceiling limit of Rs.50,000/- (Rupees fifty thousands only) shall be paid under proper acknowledgement to the person(s) entitled to receive it as identified by the Committee, and under the supervision of the Committee as one time settlement and no liabilities on the part of the deceased families will exist.

The expenditure on this account shall initially be met from out of the revolving fund of the District Collector concerned, which shall be reimbursed later from the Chief Minister's Relief Fund on receipt of necessary proposals from the District Collectors concerned, by the Government in Revenue Department.

(ii) Verification Procedure:

The Government hereby constitute a committee for Verification and Certification of the event of suicide comprising the following.

1. R.D.O./Sub Collector : Chairman/Member

2. Deputy Superintendent of Police : Member

Assistant Director of Agriculture : Member

The above Committee having the official jurisdiction of the place of the farmer who has committed suicide, shall verify each case, and will establish the correlation—between farm related operations, economic distress and social humiliation eventually leading to suicide. It shall also further sit with Banker. Moneylenders and family members of the distressed along with community elders and workout one time settlement package for extinguishing outstanding debts of family in distress.

(iii) Rehabilitation Package:

Once the verification and certification committee clears the outstanding liabilities with Rs.50,000/- provided, farm rehabilitation process of the distressed family shall commence. For this purpose the Mandal Revenue Officer/Mandal Agricultural Officer having the official jurisdiction of the place of the deceased farmer and the members of the family shall decide about the future agricultural operations, diversification of crop if necessary, change of technology and inputs and other source as advised by agricultural and other appropriate departments. The Mandal feam would primarily be responsible to rehabilitate the distressed family in a secured manner. The team shall work for minimum period of one year or as long as it is necessary to bring the family out of distress.

In addition to the above, the following measures to provide social cushion will also be taken up.

- a) Admission of Children in Social Welfare Schools and Hostels
- b) Allotment of houses under I.A.Y Scheme.
- c) Economic support under Government Schemes.
- d). Pensions etc.

Further in such cases restriction if any regarding eligibility will be relaxed by the Government in cases wherever it is considered necessary.

4. These orders will also be applicable to all the cases of suicides primarily arising out of farm income related issues from 01.07.1993 (First July One thousand Nine hundred and Ninety Eight) till the date issue of these orders. The distressed family members, who did not get any relief/family assistance earlier, may submit their applications with full particulars to the Revenue Divisional Officer baving the jurisdiction of the place of the farmer who committed suicide. The Revenue Divisional Officer, on receipt of such application shall take necessary further action in the matter duly following the procedure prescribed in this order.

5. Preventive Measures:

The Help line in every Collectorate shall continue to operate. Any farmer or his friend or relative or family member or a well-wisher may bring to the the notice or the Collector, the likelihood of such extreme act by making use of the help line. On receipt, such information shall be flashed from the Collectorate to Division Office immediately and the Revenue Divisional Officer and his machinery will get in touch with that family immediately and organize an appropriate counseling at District level and work out a package to insulate them from the pressures of money lenders. Such cases will be given preference in extending benefits of the ongoing Government Schemes pertaining to agriculture.

- 6. The expenditure on account of maintenance of the Help Line shall also be met from Chief Minister's Relief Fund.
- 7. All the District Collectors are requested to immediately initiate necessary action in the above regard.
- 8. Further operational guidelines will be issued separately.

ORDER:

The Government have looked into the several suicidal deaths by weavers took place in the state due to several reasons such as lack of work, hike in yarn prices and poverty besides ill health and no financial assistance was provided to the deceased families by the government. The family members of the deceased weavers were in miserable condition and Government also noticed that the families of weavers who committed suicide on account of distressed caused by occupation related problems like, (a) indebtness (b) lack of employment in weaving/processing (c) harassment of fellow villages on matter relating to Handlooms /delivery of finished cloth etc., and (d) failure in providing livelihood to family members leading to despair etc. It is not only a tragedy for their families by loosing their breadwinner, but also to the State by loosing a weaver.

- 2. In the G.O., 1st read above, orders were issued for payment of an ex-gratia of Rs. 1.00 lakh (Rupees one lakh only) to the family (next kin of the deceased farmers) besides loan settlement upto a sealing of Rs.50,000/- (Rupees fifty thousand only) as one time settlement to the creditors, as a measure of support to the distressed family members of the farmers who committed suicide.
- 3. In the G.O., 2nd read above, orders were issued evolving an interim special package scheme as a measure of providing assistance to the deceased weaver families on par with the special package ordered by the Government to the families of the deceased farmers.
- 4. In the G.O., 3^{rd} read above, in partial modifications of the orders issued in the G.O., 2^{nd} read above, the Government have issued orders that the benefits contemplated in the said G.O., shall be applicable to those weavers who committed suicide w.e.f. 01.04.1997 and that these cases of suicidal deaths of weavers shall be treated in the same way as was done to the weavers suicidal deaths.
- 5. The Government have further reviewed the matter and decided to evolve a special package scheme as a measure of providing assistance to the deceased weaver families. Accordingly, the Government hereby order to implement the package as indicated below:-

(i) <u>Financial Assistance</u>:

An ex-gratia of Rs.1.00 lakh only in cases suicide provisionally arises out of weaving income related issues shall be provided to the family /next of kin of the deceased weavers, as an economic support besides loan settlement upto a ceiling of Rs.50,000 (Rupees fifty thousand only) to the creditors.

The ex-gratia of Rs.1.00 lakh to be provided to the family /next of kin of the deceased weaver shall be deposited in an authorized bank by opening joint account of the Asst. Director (H&T) of the concerned district and the legal heir. It will be operated by the officer concerned, having the official jurisdiction of the place of the weaver who have committed suicide.

The loan settlement up to a ceiling limit of Rs.50,000 (Rupees fifty thousand only) shall be paid under proper acknowledgement to the person (s) entitled to receive it as identified by the Committee and under the supervision of the Committee as one time settlement and no liabilities on the part of the deceased families will exist. The expenditure on this account shall initially be met from out of the Revolving Fund of the District Collector concerned, which shall be reimbursed later from the Chief Minister's Relief Fund on receipt of necessary proposals from the District Collectors concerned by the Government in Revenue Department.

(iii) Rehabilitation Package:

For this purpose the territorial officer of Handlooms and Textiles Department and the DMO, APCO having the official jurisdiction of the place of the deceased weavers and the members of the family shall decided about the future weaving operations, marketing of cloth produced by them etc.

Further, in such cases <u>restrictions</u>, if any, regarding eligibility will be relaxed by the Government in cases wherever it is considered necessary.

The distressed family members who did not get any relief/family assistance earlier, may submit their applications with full particulars to the Revenue Divisional Officer, having the jurisdiction of the place of the weaver who committed suicide. The Revenue Divisional Officer, on receipt of such application shall take necessary further action in the matter duly following the procedure prescribed above.

(iv) Preventive Measures:

The helpline at every Collectorate shall continue to operate as in the case of farmers special package. Any weaver or his friend or relative or family member or a well wisher may bring to the notice of the Collector, the likelihood of such extreme act by making the use of helpline. On receipt of such information the Assistant Director (H&T) of the district and his missionary will get in touch with that family immediately and organize an appropriate counseling at district level and workout a package to insulate them from the pressures of money lenders. Such cases will be given preference in extending benefits of the ongoing Government schemes pertaining to weaving. The expenditure on account of maintenance of the helpline shall also be met from Chief Minister's Relief Fund.

- 6. All the District Collectors are requested to take action in respect of weavers who committed suicide and to send proposals to the Revenue (GMRE) Department, directly in respect of weavers, duly enclosing all the particulars in soft/hard copies of the details for early reimbursement.
- 7. The Director, Handlooms & Textiles and Apparel Export Parks, Andhra Pradesh, Hyderabad /All Assistant Directors (H&T) in the State are requested to follow the above orders scrupulously and follow up all such cases with the District Collectors concerned in this regard.
- 8. This orders issues with the concurrence of Revenue (CMRF) Department vide their U.O.No.2037/CMRF/12, dated 10-10-2012.
